### **Aims and objectives**

Our policy on school uniform is based on the belief that school uniform:

- promotes a sense of pride in our school;
- helps to create a sense of community and belonging towards the school;
- identifies the children with the school;
- supports our commitment to inclusion;
- prevents children from wearing 'fashion clothes' that could be distracting in class;
- is practical, smart and designed with health and safety in mind;
- is considered good value for money by most parents;

### **Expectations**

We do expect all pupils to comply with this uniform policy, which will be monitored. We promote good communication with parents to address and resolve any issues around uniform.

### **The Role of Parents**

We believe that one of the responsibilities of parents is to ensure that their child has the correct uniform and PE kit, and that it is clean, in good repair and that it is labelled with their child's name. If parents have questions about the school uniform, they are to speak with the Head teacher.

### **The Role of Governors**

The Governing Body supports the Head teacher in implementing the School Uniform Policy. It considers all representations from parents regarding the uniform policy and liaises with the Head teacher to ensure that the policy is implemented fairly and with sensitivity. It is the Governors' responsibility to ensure that the school uniform meets all regulations concerning equal opportunities. Governors ensure that the school Uniform Policy enables children to dress sensibly, in clothing that is hardwearing, safe and practical.

## **School Uniform List**

### **Winter Uniform**

- Navy sweatshirt/jumper or cardigan
- Black or grey long trousers
- Black or grey skirt or pinafore dress
- Traditional school white shirt - long or short sleeved
- White polo style shirt or t-shirt
- White/dark socks or tights
- Black leather (or vegan leather) shoes

### **Summer Uniform**

- Black or grey shorts/long trousers
- Black or grey skirt or pinafore dress
- Traditional school white shirt - long or short sleeved
- White polo style shirt or t-shirt
- Blue gingham dress
- Black shoes
- White or dark socks or tights
- Summer shoes should be buckled or tied with no open toes (sliders and flip-flops are not permitted)

### **P.E. Kit**

- Navy blue or black shorts (no logo)
- Plain white t-shirt
- Navy blue or black joggers and sweatshirt (no logo)
- Rubber soled pumps or trainers

### **Headscarves/Hijab**

These may be worn for religious reasons but must be in school colours – navy blue, black, or white

### **Jewellery**

It is not appropriate for children to wear jewellery except for a pair of small, plain stud earrings. Children in years 3 – 6 may wear a sensible watch (**not** Smart or internet enabled). All earrings must be taped or removed before PE.

### **Hairstyles**

Hairstyles should be appropriate for school, i.e. no "mohicans", no designs cut into hair, no extremely short hair (no-guard or number 1) or bright coloured highlights. All long hair (shoulder length or longer) should be tied back. Headbands or hair bobbles should be plain and in the school colours of blue, black, grey. All shoulder length hair (and longer) must be tied up for PE.

### **Makeup / nail varnish**

Children are not permitted to wear makeup or nail varnish to school.

### **School Bags**

School bags should be of a medium size with two back straps.

Lunch boxes can be carried and stored on the cloakroom shelves or in the class box
